To promote, manage and direct fuels reduction and community wildfire preparedness at the area local level, reducing the risk of wildfire in the wildland-urban interface. More specifically, to coordinate the communities wildfire risk reduction local efforts, lead community wildfire preparedness planning, along with design and implement fuel reduction projects. In all phases of work, to develop positive working relationships with landowners, communities and community leaders, fire departments, Cal Fire, nonprofit organizations and a range of other State and Federal land management agencies.

Principal of Duties:

- Pursue funding opportunities in collaboration with the Watershed Principal and Executive Director for the Pit and Fall River RCDs.
- Assist with writing grants for program(s) and carry out necessary grant monitoring and reporting.
- Strategically plan and Implement project work by utilizing local resources, contracting work to
 private contractors, and mobilizing homeowners and other volunteers. The implementation
 process includes obtaining landowner permission forms, getting archaeological clearances,
 preparing scopes of work, tracking in-kind match, overseeing and monitoring on-the-ground
 work, tracking progress, and documenting completion (reports). Tracking, maintaining and
 replacing equipment for fuels work, including trailers, chainsaws, hand tools, and a future
 brush chipper.
- Community Engagement/Education Attend, coordinate and help facilitate community, homeowner association, and other related meeting opportunities to deliver presentations and educational materials, promote wildfire risk reduction programs, and strengthen communitybased relationships.
- Community Wildfire Preparedness/Protection Plans (CWPPs) Facilitate the maintenance of existing of CWPPs. Coordinate and hold meetings for the Burney Basin FSC. Coordinate with the newly formed Fall River FSC. Coordinate with the Modoc County FSC.
- Coordinate homeowner wildfire lot assessments in collaboration with the local fire jurisdictional organization.
- Promote national wildfire preparedness programs including Fire Adapted Communities,
 Firewise Communities USA, and Ready, Set, Go!
- Collaborate with interagency groups, other state agencies, federal partners, nonprofits, local government, watershed planning groups to pursue projects of mutual interest and to share resources.
