### New Business

Office Real Estate Taxes: Office parcel would have to be put back into district boundaries in order to not pay taxes on it. M/S Pat Oilar/Chris Camarata pursue an attorney to draft a letter to get parcel back within the district, spend up to \$2,500 and re-evaluate the situation once we see what the options are. Motion passed.

Fair Posters: Give \$500 award to IMF poster winner, create a committee to decide the winner. M/S Don Martin/Pat Oilar to spend up to \$800 including printing. Motion passed.

New Signature Card: Need new bank signature card to add new board members and remove old board member. M/S Don Martin/Pat Oilar Remove Dan Klatt and add Chris Camarata to signature card. Motion passed.

Organization Donations: Discussion on donating birds (pheasant) to the Youth Trap Team, California Deer Association and Ducks Unlimited Organizations for their fundraisers. Birds would be planted on the Swamp in order to be hunted. Would bring attention to organizations and Swamp Hunting program, hunts would not take place during the RCD pheasant hunts. M/S Pat Oilar/Don Martin to donate approximately \$750 per year. Motion passed.

Letter from McArthur Livestock: Reviewed and discussed letter received from McArthur Livestock Attorney. Pat Oilar/Chris Camarata to have RCD attorney respond to the letter. Motion passed.

McArthur Swamp Checking Account: Reported that several fraudulent checks have been attempted on the old McArthur Swamp Account which was closed due to account information being accessed outside of the RCD.

Gun Club Building Envelope: Shasta Land trust did not have any concerns with the designated building envelope. Will get plans finalized.

Partners Projects Updates: Cal-Fire is currently out on the property continuing the Juniper removal and piling, will come back in the fall to burn the piles.

Grazing Seasons – Swamp and FRPU: Both properties are in full swing.

McArthur Swamp Pivot/Wetland Delineation: Reviewed and discussed the results of the wetland delineation in the pivot area. Julie directed to hire a professional water monitor to test the water no less than 4 times a year.

Vollmar Vegetation Sampling: Vollmar reached out again in hopes to do further sampling and testing on the swamp, board directed Julie to respond declining further sampling.
