New Business

Development of a Prescribed Burn Association – Todd, Debbie, Tim, and Sarah all spoke on the topic. It was explained to the board that the Association would be run through the RCD and that the McConnell Foundation will proved financial support and administration. There was discussion on insurance requirements and landowner fees, Tim explained how it would work and suggested the CalFBA.org website for more information. He told the board that the State of California has laws in place to cover landowners in case of fire as long as they are following the guidelines such as creating a burn plan that has a prescription, taking reasonable precautions, etc. Cal Fire only wants to be notified when prescribed burns will be taking place. The RCD's role for now is to place information on the website and social media platforms and signing a potential future MOU. M/S/C Chris/Clay to draft a letter of support for the PBA and email it to Tim and cc Todd.

ADA compliance for website – Tabled to next meeting.

Hat Creek Rifle and Pistol Club – John Funk, President of the Club, addressed the board to discuss the new lease that the RCD will have with the Club. He gave a background on the Club and there was discussion on the lease amount that the Club pays to PG&E. The current lease cost is \$5,000 and it runs Jan 1st – Dec 31st each year. PG&E also requires a \$4 million policy for liability insurance. The board decided to create a new lease agreement and to ask Randall Harr to review it. There was discussion on have a 10 year agreement and amending the acreage to only include the actual area, approximately 80 acres, where the gun club is located.

Trap Shooting Facility – Clay gave a presentation and handouts on the proposed facility. The group has created a map and has insurance through Lockton & Associates. They have applied for funding from the National Shooting Sports Foundation and are working with local businesses to have the brush removed and gravel donated. M/S/C Dan/Chuck to allow volunteers to clear out the area and place gravel in areas of need. There was discussion about having the RCD named on the liability policy as additional insureds before anyone does any shooting on the property.
